## Legal notice and information on the conditions of use of COMERCIAL TURISTICA S.L

### Identification data of the owner of the website

### Definitions

"Site", [domain www.hoteldelamarlloret.com](http://domain.www.hoteldelamarlloret.com) that is made available to Internet Users.

"User", natural or legal person who uses or browses the Site.
